Precautions: Store treated seed in cool place, out of direct sunlight. Always use non-chlorinated water for pesticide dilutants when mixing with inoculants. Read and follow all label directions.

"Slurry"¹ refers to co-mixing liquid inoculant together with the seed treatment in the treater tank. If possible avoid co-mixing liquid inoculant together with the pesticide seed treatment, use a separate tank for inoculant. The inoculant plus the named seed treatment should be kept together in the tank no longer than four hours before application to the seed.
